

QUADRANT REAL ESTATE ADVISORS LLC PRIVACY STATEMENT

The following statement explains Quadrant Real Estate Advisor's policy relating to the collection, storage and use of personal information. The purpose of this policy is to assure anyone who does business with Quadrant Real Estate Advisors that Quadrant Real Estate Advisors will comply with both the letter and spirit of the Privacy Act 1988.

Compliance with Privacy Legislation

Quadrant Real Estate Advisors takes seriously its obligation to safeguard personal information regarding its clients. This policy formalizes and strengthens this commitment to Quadrant Real Estate Advisor's clients. Quadrant Real Estate Advisors complies with the National Privacy Principles contained in the Privacy Act 1988. This Privacy Policy covers all of the entities within the Quadrant Real Estate Advisors.

Collection of Personal Information

Personal information is generally defined as information or an opinion that can identify a person. The type of personal information that Quadrant Real Estate Advisors collects from its clients will depend upon what dealings clients may have with Quadrant Real Estate Advisors.

Use and Disclosure of Personal Information

Quadrant Real Estate Advisors operates a number of businesses, which handle personal information. In general, Quadrant Real Estate Advisor's policy is only to use or disclose personal information for the purpose which was either specified or reasonably apparent at the time when the information was collected. Quadrant Real Estate Advisors may also use or disclose the information collected for any other related purpose for which a client would reasonably expect it to be used.

If Quadrant Real Estate Advisors wishes to use or disclose the personal information in other circumstances it would obtain the client's consent to do so.

Sharing Information with Other Organizations

Quadrant Real Estate Advisors does not sell personal information to companies outside Quadrant Real Estate Advisors. The only circumstances in which external organizations may be given access to Quadrant Real Estate Advisor's client personal information are when Quadrant Real Estate Advisor's contractors and service providers are assisting Quadrant Real Estate Advisors in the operation of its business or to provide a client service (for example, a company which helps maintain Quadrant Real Estate Advisor's computer systems or sends out Quadrant Real Estate Advisor's mail). Quadrant Real Estate Advisors requires these organizations to agree to Quadrant Real Estate Advisor's Privacy Policy and to strict conditions governing how this information may be used.

Marketing

Quadrant Real Estate Advisors may send advertising mail to its clients where the advertising mail is related to the purpose for which the information was collected.

If the client no longer wishes to receive promotional information from Quadrant Real Estate Advisors, the client should advise the Quadrant Real Estate Advisors Compliance Officer. Normally Quadrant Real Estate Advisor's records would be amended within 30 days.

Cookies

A cookie is a small data file that may be placed on the computer of a web user (usually in the browser software folder) the first time a computer visits a web site which operates cookies. Cookies are necessary to facilitate on-line transactions and ensure security. If clients do not wish to receive any cookies they should set their browser to refuse cookies. Quadrant Real Estate Advisors does not use cookies to keep personal profiles of its clients' use of the Quadrant Real Estate Advisors web site at <http://www.quadrantrealestateadvisors.com>.

Security of Personal Information

Quadrant Real Estate Advisors will take reasonable steps to protect personal information that it collects and ensure that the information is accurate and up-to-date. Client information is held on secure servers or in storage located in controlled environments. Quadrant Real Estate Advisors employees are required to maintain the confidentiality of any personal information held.

Access to Personal Information

Clients are welcome to request personal information Quadrant Real Estate Advisors holds about them. To obtain a copy of the personal information that Quadrant Real Estate Advisors holds, please contact the Quadrant Real Estate Advisors Compliance Officer. Quadrant Real Estate Advisors may require personal identification.

Changing Information

If the client wishes to change personal information that is inaccurate or out-of-date, they may write to the Quadrant Real Estate Advisors Compliance Officer.

Changes in the Future
